The analysis is based on 4 indicators to assess the degree of application of C&C principles in the University of Camerino

Dimension 1 - Open recruitment and portability of grants

Dimension 2 -Meeting the social security and supplementary pensions needs of mobile researchers

Dimension 3 - Attractive employment and working conditions

Dimension 4 -Enhancing training, skills and experience of European researchers

We have proposed 29 statements divided into 4 dimensions. The possible answers were: 1= disagree; 2 = moderately disagree; 3 = moderately agree; 4 = agree. Furthermore it was asked to indicate the 3 most important statements for each dimension.

Dimension 1 - Open recruitment and portability of grants

Selection

Selection committees should bring together diverse expertise and competences and should have an adequate gender balance and, where appropriate and feasible, include members from different sectors (public and private) and disciplines, including from other countries and with relevant experience to assess the candidate. Whenever possible, a wide range of selection practices should be used, such as external expert assessment and face-to-face interviews. Members of selection panels should be adequately trained.

Dimension 2 -Meeting the social security and supplementary pensions needs of mobile researchers

Stability and permanence of employment

Employers and/or funders should ensure that the performance of researchers is not undermined by instability of employment contracts, and should therefore commit themselves as far as possible to improving the stability of employment conditions for researchers, thus implementing and abiding by the principles and terms laid down in the EU Directive on Fixed-Term Work

Dimension 3 - Attractive employment and working conditions

Recognition of the profession

All researchers engaged in a research career should be recognised as professionals and be treated accordingly. This should commence at the beginning of their careers, namely at postgraduate level, and should include all levels, regardless of their classification at national level (e.g. employee, postgraduate student, doctoral candidate, postdoctoral fellow, civil servants).

Non-discrimination

Employers and/or funders of researchers will not discriminate against researchers in any way on the basis of gender, age, ethnic, national or social origin, religion or belief, sexual orientation, language, disability, political opinion, social or economic condition.

Research environment

Employers and/or funders of researchers should ensure that the most stimulating research or research training environment is created which offers appropriate equipment, facilities and opportunities, including for remote collaboration over research networks, and that the national or sectoral regulations concerning health and safety in research are observed. Funders should ensure that adequate resources are provided in support of the agreed work programme.

Dimension 4 -Enhancing training, skills and experience of European researchers

Access to research training and continuous development

Employers and/or funders should ensure that all researchers at any stage of their career, regardless of their contractual situation, are given the opportunity for professional development and for improving their employability through access to measures for the continuing development of skills and competencies.

Such measures should be regularly assessed for their accessibility, takeup and effectiveness in improving competencies, skills and employability.

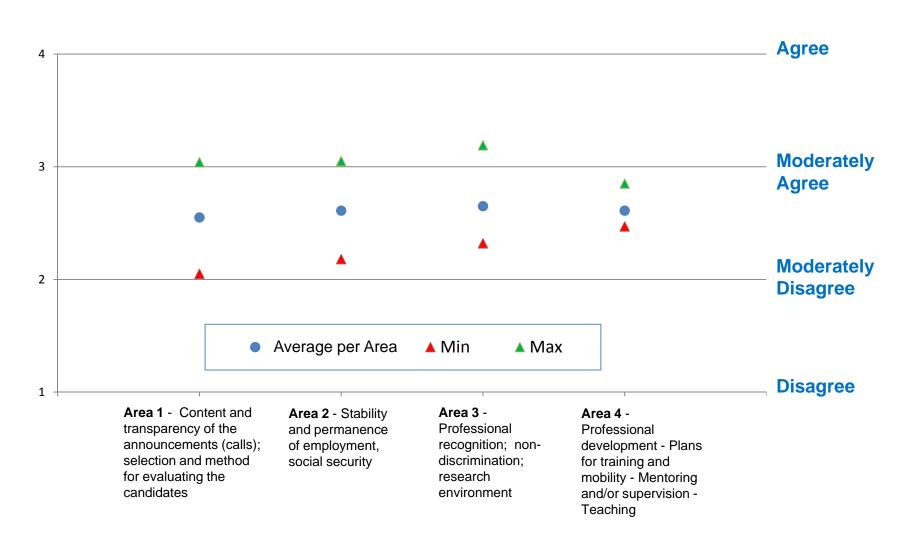

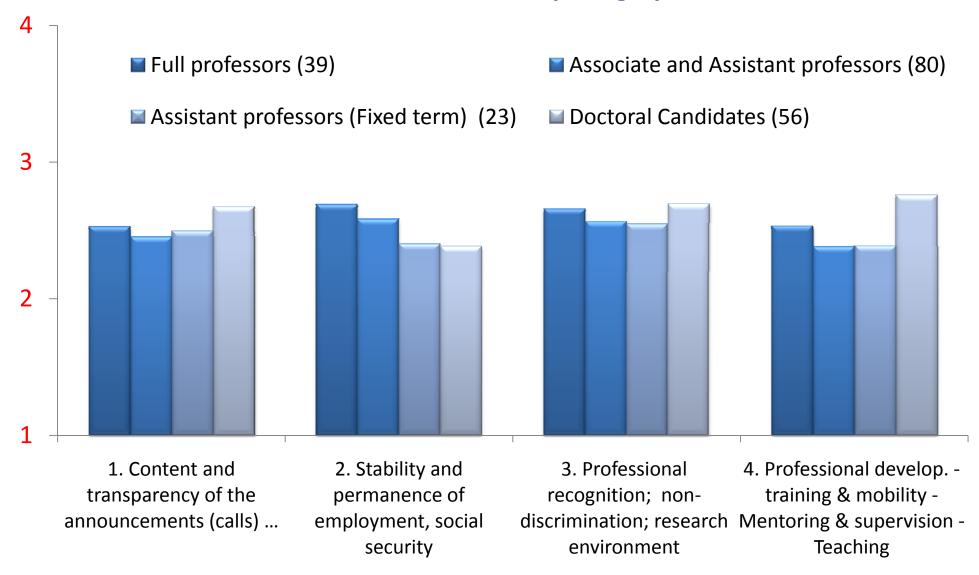

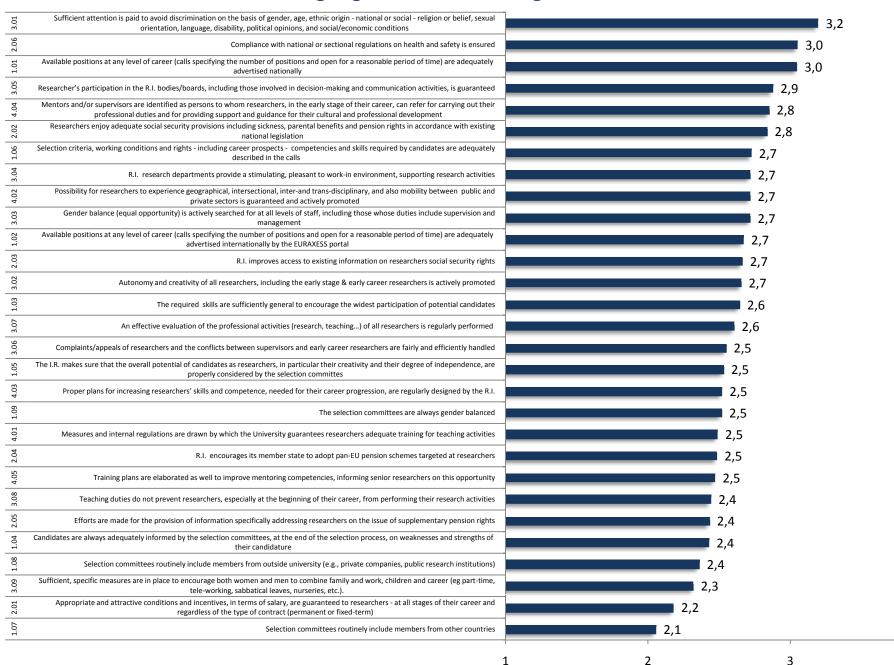
Agreement in each dimension



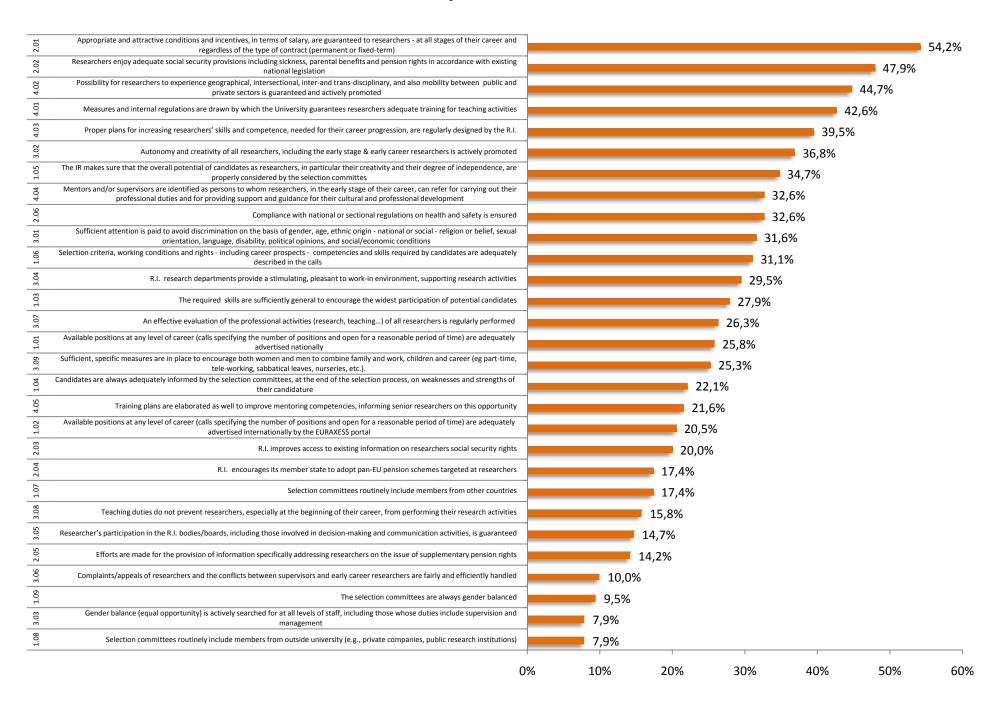
Average agreement for each dimension by category



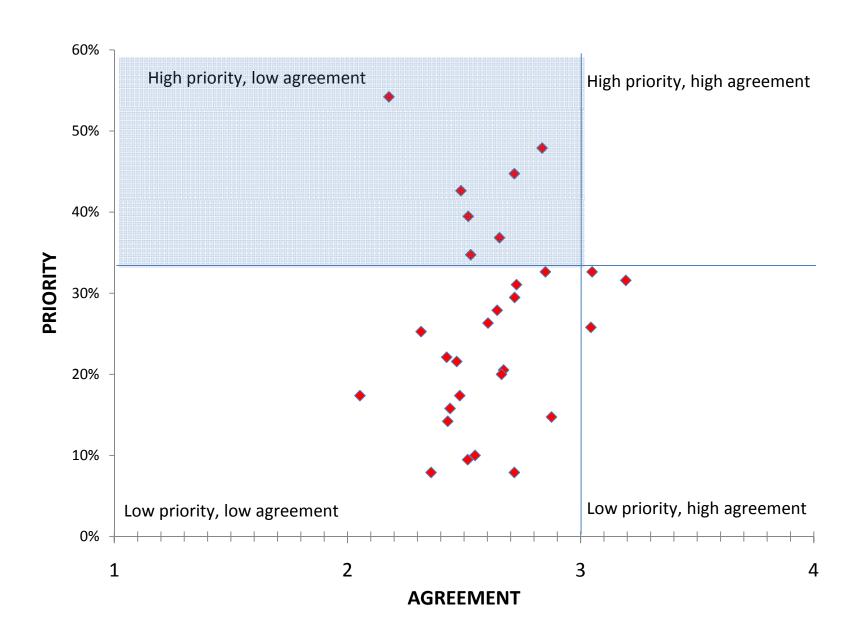
Average agreement for the single statements



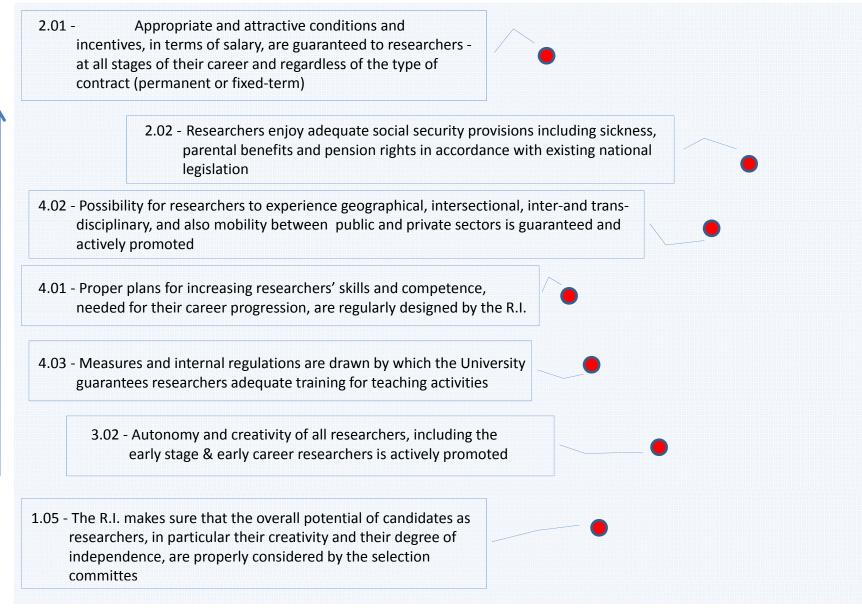
Priority of the statements

In Summary

• 38% of the staff of University of Camerino has answered to the questionnaire.

The highest feedback (68%) was from Assistant Professors with a fixed term contract.

- Most of the answers fall in the middle ("can be better but is not so bad") regardless of interviewed categories.
- Integrated analysis of priorities and agreements shows that the interviewed are most interested in
- economic treatment,
- social security issues
- tools to improve skills and competence for research and teaching.
- On the basis of this analysis the University of Camerino has defined a Human Resources Strategy.
